# **Legal Notices**

The 2025 Important Notices document contains the following resources:

#### **Medicare Part D**

This notice advises whether the prescription drug coverage under the Activision Blizzard medical plans are considered "creditable coverage".

#### **Notice of Special Enrollment Rights for Health Plan Coverage**

You have the ability to enroll in benefits during the year if you experience a qualifying life event.

### **Women's Health and Cancer Rights Notice**

If you have to have a mastectomy, the Women's Health and Cancer Rights Act entitles you to certain benefits from your health plan. This notice describes those benefits.

#### Newborns' and Mothers' Health Protection Act Notice

Federal law prohibits certain restrictions on hospital stay benefits in connection with childbirth.

#### **HIPAA Privacy Notice**

Your rights and the Plan's responsibilities with regards to your personal health information.

#### **Provider-Choice Rights Notice**

Your rights when choosing a primary care provider under the Kaiser and Centivo plans.

#### Benefits@Play Wellness Program

A summary of the program's administration, participation, and how health information is managed and protected.

### **Outbreak Period Notice (2024)**

## Summary Annual Report - Health & Welfare

The Summary Annual Report summarizes the Plan's submission of Form 5500 to the Department of Labor and notifies plan participants of their right to receive a copy of the full annual report.

## **Premium Assistance Under Medicaid and CHIP**

Your state Children's Health Insurance program (CHIP) or Medicaid program may provide subsidies you can use to pay for health plans sponsored by your employer. This notice provides information about these programs and who to contact for more information.

#### **ILDOL Health Plan Disclosures**

This document discloses plans available to Illinois residents in a format that provides a comparison to essential health benefits regulated by the state.

#### **Transparency in Coverage**

Machine-readable files are required to ensure compliance with the Federal Transparency in Coverage Rule. The files include negotiated service rates and out-of-network allowed amounts between the Participating Medical Plan and many healthcare providers. The files are designed to allow researchers, regulators, and application developers to more easily access and analyze data.
